Yarmouk Water Company (YW) invites all interested eligible bidders to bid for contract No. YWC – FARA7 –9.1– 2022 " Supply information technology equipment" under the following conditions:

1. The scope of work includes but is not limited to the following:
 - Supply and delivery of information technology equipment to YW Hofa warehouses.
2. Interested eligible bidders are invited to purchase the full set of the tender documents from YWC offices at Irbid- Baghdad street for the non-refundable fee of (50) fifty Jordanian Dinars. During working hours (9:00 am – 3:30 pm) Sunday to Thursday. The document should be collected by an authorized representative.
3. Interested bidders shall bring a valid professional practice certificate, commerce chamber registration, and company register.
4. Only bidders who fulfill the following criteria are eligible to respond to the tender. Offers received from the bidders who do not fulfill all or any of the following eligibility criteria are liable to be rejected:
 - a) The bidder shall provide a registration certificate showing that his firm has been registered and established at least 5 years before issuing this tender and shall provide a proven general experience of minimum of 5 years in the field of supplying, delivering, and commissioning of information technology equipment.
 - b) The nationality of the supplier, manufacturer, and/or any partner shall be according to USAID geographical code #937 (The United States, Jordan (the cooperating/recipient country), and developing countries other than advanced developing countries, but excluding any countries that are prohibited source).
5. The material in this tender should comply with Geographical code 937.
6. The bidder shall attach a bank guarantee or a certified check within the sealed envelope for an amount of 1,200 JD and must be valid for 120 days after the deadline for submission with specifying the number and name of the tender on the envelope and deposited with the submitted offer (any proposal submitted without submission Tender Entry Guarantee will be rejected directly).

7. The deadline for the tender document purchasing is **September 22, 2022**, at 03:30 pm.
8. The deadline for submitting bids is **September 29, 2022**, at 12:00 pm.
9. Tender advertisement costs will be borne by the winning bidder.
10. This tender is funded by USAID and is subject to zero sales taxes for the items listed in this tender **only**.
