Installation methods will include, but are not limited to, conventional open trenching, asphalt pavement, curb, and concrete sidewalk cutting. This requirement also involves connecting existing portions of existing sanitary pipe coming out of east side of Bldg. 350, including two waste lines and one grease line discharge, from existing grease trap at existing invert elevations to remain in service. Restore paved and unpaved surface to near

original conditions as necessary. Additionally, the requirement calls for the existing Lift Station 350 to be demolished and disposed of.
