SITE VISIT

The Government will hold a site visit at Carlisle Barracks Directorate of Public Works, 330 Engineer Avenue on January 5, 2018 at 9:00 AM Eastern Standard Time. All interested firms may attend with No more than four (4) representatives per company for the pre-brief and No more than two (2) representatives per company are allowed to attend the site visit tour due to limited seating. All attendees must be pre-registered. Please submit by email the names of attendees to the contract specialist no later than January 3, 2018, 3:00 PM Eastern Standard Time (EST). Questions in reference the solicitation are to be submitted in writing, via e-mail, to this address: sherry.d.james8.civ@mail.mil. Cutoff for submitting questions is 12:00 PM EST January 9, 2018. No other questions will be answered after this date. Unescorted visitors coming to Carlisle Barracks, who do not have a Federal government-issued identification card, will be vetted through the National Crime Information Center Interstate Identification Index (NCIC-III). Contractors will have to register at Claremont Gate, Building 870, Carlisle Barracks Visitors Center, and obtain a "Visitors Pass" to gain access to Carlisle Barracks (enhanced Driver's License and PROOF OF VEHICLE INSURANCE IS REQUIRED). It is recommended to obtain the Visitors Pass the day prior to the site visit, either in person or communicated thru fax and available for pickup upon arrival to the Visitor Center.
