

JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION

Pursuant to the Federal Acquisition Regulation (FAR) Subpart 6.302-1(ii) and the Bureau of Prisons Acquisition Policy (BPAP) Part 6.304(b) and AGD 06-006, the Federal Bureau of Prisons (BOP) has determined that the procurement of Outside Medical Services for the United States Penitentiary, located in Jonesville, Virginia, meets the criteria established for other than full and open competition. This limitation on competition is justified as supported by the following information:

1. IDENTIFICATION OF THE AGENCY AND THE CONTRACTING ACTIVITY:

2. NATURE AND/OR DESCRIPTION OF ACTION BEING APPROVED:

This action is for the acquisition of emergency outside medical services through Wellmont Health System for our Health Services Department for the United States Penitentiary LEE, located in Jonesville, Virginia. The emergency services are necessary to maintain care for inmates here at USP Lee.

3. DESCRIPTION OF SUPPLIES AND SERVICES REQUIRED TO MEET THE AGENCY NEEDS (INCLUDING ESTIMATED VALUES):

The USP has a requirement to purchase the outside service from Wellmont Health System. The total amount is \$24,509.21.

4. IDENTIFICATION OF STATUTORY AUTHORITY PERMITTING OTHER THAN FULL AND OPEN COMPETITION:

This procurement will be outside medical services from Wellmont Health System. This is deemed to be highly-specialized service.

Competition was not sought due to emergency medical services required.

The Contracting Officer anticipates the cost to the Government will be fair and reasonable.
9. DESCRIPTION OF MARKET RESEARCH:
Due to the urgency of this procurement no market research was conducted.
10. OTHER FACTS SUPPORTING THE USE OF OTHER THAN FULL AND OPEN COMPETITION:
This procurement was for an inmate that needed immediate outside medical care.
