PART 1 General Information

- 1. <u>GENERAL</u>: This is a non-personnel services contract to provide complete repair of the body damage on the provided Motor Coach Industries bus. The Government shall not exercise any supervision or control over the contract service providers performing the services herein. Such contract service providers shall be accountable solely to the Contractor who, in turn is responsible to the Government.
- 1.1 <u>Description of Services/Introduction</u>: The contractor shall provide all personnel, equipment, supplies, facilities, transportation, tools, materials, supervision, and other items and non-personal services necessary to perform complete repair of the body damage on the provided Motor Coach Industries bus as defined in this Performance Work Statement. The contractor shall perform to the standards in this contract.
- 1.2 <u>Objectives</u>: All parts must be replaced in accordance with Air Force technical order 36-1-191 1.5.1.2 which states any parts replaced must meet or exceed original equipment manufacturer specifications.
- 1.3 <u>Scope</u>: Perform complete repair of the body damage on the provided Motor Coach Industries bus. *Services include* repairing fan door panel and hinge, door rub rail, door handle, access door, rear panel under taillight, letter board panel, and bumper corner. Services also include replacing right rear access door, fab panel behind rear wheel, wheel well fender, all fender brackets, def panel, rub rail for def panel, left side Air Force decals, 20 lug nut covers. The contractor shall accomplish the replacement of any parts with original equipment manufacturer specifications.
- 1.4 Period of Performance: The period of performance shall not exceed 90 days.
- 1.5 <u>Type of Contract</u>: The government will award a (Type of contract to be determined by CCE and the customer).
- 1.6 Special Qualifications: The contractor must be ASE, I-car and Gold Class certified.

- 2.1. DEFINITIONS:
- 2.1.1. CONTRACTOR. A supplier or vendor awarded a contract to provide specific supplies or service to the government. The term used in this contract refers to the prime.
- 2.1.2. CONTRACTING OFFICER. A person with authority to enter into, administer, and or terminate contracts, and make related determinations and findings on behalf of the government. Note: The only individual who can legally bind the government.
- 2.1.3. DEFECTIVE SERVICE. A service output that does not meet the standard of performance associated with the Performance Work Statement.
- 2.1.4. KEY PERSONNEL. Contractor personnel that are evaluated in a source selection process and that may be required to be used in the performance of a contract by the Key Personnel listed in the PWS. When key personnel are used as an evaluation factor in best value procurement, an offer can be rejected if it does not have a firm commitment from the persons that are listed in the proposal.

- 2.1.5. QUALITY CONTROL. All necessary measures taken by the Contractor to assure that the quality of an end product or service shall meet contract requirements.
- 2.1.6. SUBCONTRACTOR. One that enters into a contract with a prime contractor. The Government does not have privity of contract with the subcontractor.
