BACKGROUND AND SCOPE

The Federal Bureau of Prisons (Bureau) is an agency of the Department of Justice (DOJ). It consists of 122 institutions throughout the United States, including Hawaii and Puerto Rico; 6 regional offices, a Central Office (headquarters), 2 staff training centers, and 22 Residential Reentry Management offices.

PURPOSE

This announcement is posted as a **Request For Information (RFI)** *only* for an intended upcoming solicitation that will be posted on the SAM.gov website. This RFI is being issued to determine whether or not there are qualified sources that will be able to meet the requirements of this intended upcoming solicitation. This upcoming solicitation will be for Residential Reentry Center (RRC) services, and Home Confinement services in Western Missouri, within one of the following counties: Boone, Howard, Cooper, Saline, Pettis, Lafayette, Jackson, Johnson, Clay and Ray, for male and female offenders held under the authority of various United States statutes. The geographical radius for home confinement placements is: within 200 miles of the facility.

The solicitation is anticipated to be for an IDIQ contract with tiered pricing. There will be a guaranteed minimum and an estimated maximum number of placements, to include in-house, and home confinement residents. It is anticipated that all services will be solicited under a single procurement, and will require that the successful offeror provide all services.

The requirement is anticipated to be for an estimated maximum of 55 In-House beds, and 40 Home Confinement placements. The ability to accept sex offenders in-house is required.

The Bureau would like input from providers of services in the community as to the feasibility of providing these services in this geographical area.

QUESTIONS AND REVIEW

Please be advised that providing responses to these questions will not automatically include responders in the acquisition process should the Bureau establish an acquisition plan.

All information received in response to this RFI notice that is marked as proprietary will be handled accordingly.

Please provide responses to the following questions:

1. Please describe your experience in providing RRC and Home Confinement services, to include monitoring of these types of programs?
2. Are there any state or local ordinances/restrictions that would prohibit or that would considerably slow down the procurement process for these services?
3. Are there any known local area concerns in relation to providing these services? Do you think the area would be supportive of a BOP RRC program? Are there any known groups or organizations that would oppose the operation of a residential (halfway) house in this area?
4. Do you feel that it would be difficult to find a suitable location for an RRC in this area? If so, explain in detail why it would be difficult and provide supporting documentation.
5. What zoning issues, if any, do you anticipate with this requirement? What would have to be done to overcome any identified issues?
6. Is local or public transportation available in this area? If not, is there an alternative method of transportation for inmates to get to and from work or get to and from their programming appointments?
7. Is the location conducive of the BOP RRC requirement for inmates to find jobs within thirty (30) days of placement?
8. Are there unique laws or regulations applicable to RRC and/or Home Confinement services in the area identified for this requirement? If so, what are they?
9. Are there any laws or ordinances precluding the housing of certain types of inmates (e.g. sex offenders), that may affect a procurement of this type? If yes, please provide a copy of the law and/or ordinance. Also, if yes, what, if anything, can the Bureau do to help offerors address those laws or ordinances through the procurement process?
10. Are there any known environmental issues/concerns with this type of procurement?
11. Please provide any additional comments that may be helpful in assessing this method of procurement.

Please be advised that providing responses to these questions will not automatically include you in the acquisition process for the upcoming solicitation. In addition, this RFI is intended solely for the use to improve communications between potential contractors and the Bureau. If for some reason, the responses are requested by outside parties (i.e. FOIA request), the information is not protected as source selection information (FAR 2.101 and 3.104). If you intend for the information to be exempt from disclosure under FOIA Exemption 4, please indicate this in your response and on each page you want exempt. Furthermore, indicate that your response is proprietary information that may not be used, reproduced, or disclosed to any other parties for any purpose without expressed written permission.
