



**Request for Information (RFI) No.: RFI-ICE-DFD-2019, entitled
“Detainee Funds Disbursement (DFD)”**

1. BACKGROUND

U.S. Immigration and Customs Enforcement (ICE), the largest investigative arm of the Department of Homeland Security, was created in 2003 through a merger of the investigative and interior enforcement elements of the former U.S. Customs Service and the Immigration and Naturalization Service. By enforcing Federal laws governing border control, customs, trade, and immigration to promote homeland security and public safety, ICE identifies and eliminates vulnerabilities in the nation’s border and threats to the nation’s economy, transportation, and infrastructure security.

ICE contains three directorates: Enforcement and Removal Operations (ERO), Homeland Security Investigations (HSI), and Management and Administration (M&A). ERO manages all logistical aspects of the removal process, including domestic transportation, detention, alternatives to detention programs, bond management, and supervised release. In addition, ERO repatriates’ individuals ordered removed from the United States to more than 170 countries around the world.

ERO is currently completing a series of improvement and modernization efforts collectively known as “ERO 2.0”. As part of one initiative, the ERO - Custody Management Division - Detention Initiatives Team surveyed the 24 Areas of Responsibility (AORs) to determine whether an ongoing funds disbursement issue existed among detainees removed from ICE custody or the United States. The survey’s results confirmed that an issue exists, and a viable solution is needed.

2. DESCRIPTION OF REQUIREMENT

ERO Officers (Officers) have a responsibility to find ways for detainees to cash checks or use debit Automated Teller Machine (ATM) cards, often taking them away from more essential law enforcement duties. When Officers or detainees attempted to access traditional ATMs using debit cards to extract the full dollar amounts, problems arose due to accessibility issues and varied ATM provider regulations. Similarly, use of check cashing businesses was found to be unsustainable.

Completed market research indicates that certain ATMs or self-service kiosks (kiosks) could resolve the existing cash access concern. This RFI seeks responses from providers of ATMs or kiosks with the capability to support 217 or more units nationwide.

3. REQUEST FOR INFORMATION

THIS IS A REQUEST FOR INFORMATION (RFI) ONLY. Provided information is subject to change and is not binding on the Government.

The RFI is issued in accordance with Federal Acquisition Regulation (FAR) 15.201(c)(7) and is solely for market research, planning, and information purposes. The contents of this document, and any or all related items, shall NOT be construed as a commitment by the Government to issue a subsequent solicitation (Broad Agency Announcement, Request for Proposal, etc.) or reimburse incurred response costs. All costs associated with responding to this RFI are incurred solely at the Respondent's expense and remain that party's responsibility.

Specifically, information is requested from vendors qualified to install and provide ATMs or kiosks, and perform all related services (including, but not limited to: continued maintenance supplies and materials [including receipt paper], cash replenishment, Visa cash/debit cards and check deposit services) at ICE ERO Field Offices, Sub-Offices, ICE Dedicated facilities, and select ERO detention facilities nationwide.

ICE seeks only **information** from potential providers describing their technical capabilities and experience supporting similar requirements. In addition to noting adherence to industry standards, Respondents shall indicate whether the offered solution includes the following capabilities:

- ensuring that all Contractor personnel are readily identifiable as Contractor employees, either by appropriate attire or by identification badge, when onsite.
- obtaining all licenses and permits required by Federal, State, and Local authorities.
- observing all applicable rules and regulations.
- providing, delivering, installing, and activating all ATMs or kiosks, no later than 30 days after a defined date.
- securing installed ATMs or kiosks, including advising Officers and other staffers on adequate security methods.
 - This includes but is not limited to providing guidance and best practice information on: card theft, card skimming, card jamming, card swapping, shoulder surfing vandalism, physical attack, ATM or kiosk take away, mugging, and ATM or kiosk jackpotting.
- being responsible for the daily operation, maintenance, connectivity, damage, loss, theft, fraudulent malfunction, and repair of the ATM or kiosk.
 - This includes but is not limited to servicing machines (completing needed repairs, software updates, hardware updates, etc.) between 6 a.m. and 6 p.m. local time and within 48-72 hours.

- dispensing both bills and coins, including the exact amount of available cash when a certified check is deposited or when a U.S. Bureau of Prisons issued Debit card and the issued Personal Identification Number are presented.
- providing monthly reports of the total volume of transactions and the total time the ATM or kiosk is available for service, including the time for periodic maintenance.

When addressing the above items, vendors are asked to state whether the capabilities are commercially available.

Please see Appendix - A for the complete list of locations.

Responses to this RFI may be evaluated by technical experts drawn from staff within DHS/ICE, other Federal agencies, and or selected support contractor personnel. Any selected support contractors will be bound by appropriate non-disclosure agreements to protect proprietary and source selection information. DHS/ICE law enforcement sensitive guidelines will govern response review.

RFI Respondents should not anticipate feedback regarding their submission, though an acknowledgment of receipt will be provided.

4. WHAT IS REQUIRED TO RESPOND

Companies able to satisfy all aspects outlined in Section 3 are invited to submit a response. Please limit submissions to a maximum of 10 pages (including cover page, white paper and product description(s), etc.).

Each submittal shall follow the below guidelines:

Cover Page (maximum 2 pages)

- Company Information
 - Name, address, and website of Respondent
 - Name, telephone number, title, & e-mail address of main Point-of-Contact
 - Name of contract administration office
 - Unique Identifier Number (formerly DUNS No.)
 - Overview of Relevant Company History, including business size, ownership status (foreign or domestic), etc.
 - List of pertinent and currently held DHS, General Services Administration (GSA), or other Federal Contracts, including contract numbers

White Paper (maximum 8 pages)

- Provide a technical description addressing the capabilities listed in Section 3. This includes:
 - ability to meet technical requirements, **mandatory**;
 - whether integration services, provided by an integrator, are required to complete all requirements, **mandatory**;

- current operational use of proposed product(s) and any available performance metrics;
- per user pricing reflecting different personas' depth, breadth and frequency of usage (i.e. developer, reviewer, approver, etc.).

Notes:

- All submissions become Government property and will not be returned.
- Responses to the RFI may be used to develop Government documentation.
- Unsolicited proposals received in response to this RFI will not be considered.
- Information shall not be delivered beyond the parameters defined above.
- This RFI does not commit the Government to contract for any supply or service. Similarly, ICE is not seeking proposals.
- Not responding to this RFI does not preclude the vendor from participating in any future solicitation.
