The Transportation Security Administration (TSA), Chicago O'Hare International Airport and Office of Contracting and Procurement propose to solicit and issue a purchase order based on soliciting only one source. (FAR 13.106-1 (b))

SECTION V: Description of Rationale

TSA has Blanket Purchase Agreements (BPA) with small business vendors to acquire Explosive Trace Detection (ETD) consumable supplies. Due to an acquisition of one of the small businesses BPA holders by a large business, the BPAs no longer cover consumable supplies for the Implant Sciences B220 machine.

The product described in Section III above is required to be tested and approved by the Transportation Security Lab (TSL). The TSL is in the process of testing consumable supplies for the Implant Sciences B220 machine. Until the items are approved and placed on the ETD BPAs, the original equipment manufacturer is the only source of consumable items that can be used in the B220 machine.

SECTION VI: Contracting Officer's Determination that the Order Represents the Best Value

Pricing for this contract action is expected to be the same as prices previously paid by the Government when the items were available for purchase on the BPAs, which had already been determined to be a fair and reasonable price.

SECTION VII: Market Research Description

None conducted. It is known that there is only one source with a tested and approved product. TSA is working diligently with the ETD small business BPA holders and the TSL to get generic consumable supplies tested, approved, and placed on the ETD BPAs.
