

## SIMPLIFIED ACQUISITION PROCEDURES (SAP) FAR 13.106-1(b)

UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED. During my market research using WEBFLIS, FEDLOG, Illustrated Parts Catalog, ILS, and open market sources, there were no other approved supply sources identified nor were any alternate parts numbers found. All technical data available to the Coast Guard has been thoroughly researched to ascertain the existence of alternate part numbers. Lockheed Martin Inc. is the only source in possession of the manufacturing data necessary to satisfy this requirement.

A DESCRIPTION OF EFFORTS MADE TO ENSURE THAT QUOTATIONS OR OFFERS ARE SOLICITED FROM AS MANY POTENTIAL SOURCES AS PRACTICABLE (INCLUDE YOUR MARKET RESEARCH EFFORTS HERE). The Lockheed Martin Inc. is the only company with the engineering data capable of Manufacturing this component. Lockheed Martin Inc. is the OEM. Lockheed Martin Inc. has not sold the Procurement data to any other vendor. Lockheed Martin Inc. has the equipment, tooling, and drawings necessary to manufacture the Pressure Regulator Deicer and Prop Control Panel

EXPLAIN WHY AN ADEQUATE PURCHASE DESCRIPTION OR OTHER INFORMATION SUITABLE TO SOLICIT BY FULL AND OPEN COMPETITION HAS NOT BEEN DEVELOPED OR ARE NOT AVAILABLE. The initial acquisition of the Pressure Regulator Deicer did not include the Manufacture data necessary to foster competition. In the event the USCG determines a system refresh is required, such an acquisition will be conducted under full and open competitive procedures.
