The requested Model EX35001 is a 35 Kg capacity balance with a repeatability of +/- 0.1 grams and a linearity of +/- 0.2 grams. This model is in the Navy Calibration Equipment List (NCE) as the primary standard to be used by all Naval Sea System Commands (SYSCOMS). The balance is used to calibrate 25 and 50 lbs weights across all Navy labs. NAVAIR has procured 20 of these balances, and is in the process of developing 3 Instrument Calibration Procedures (ICPs) for workload items.
