

Additionally, they are the only licensed provider of services for the surveillance platform in use within a 175-mile radius of the Facilities. If another vendor were chosen, they would have to first go through the DCF-required security and background checks, and then they still wouldn't have manufacturer authorization to perform service or upgrades while maintaining hardware and software warranty status. Choosing Split Pine Technologies, LLC will ensure that the installation maximizes the success of these video surveillance systems in protecting our resident population and our workforce. Also, our current installations/sites are project certified and registered by Axis Communications and Milestone Systems to Split Pine Technologies, LLC as the only reseller or authorized entity to perform upgrades and configuration changes to the system.
